2. NJ Code Changes

- A. Please be aware that on September 21, 2015 the New Jersey Department of Community Affairs (DCA) adopted revised energy codes as follows:
- International Energy Conservation Code/2015 (Residential)
 - ASHRAE 90.1-2013 (Commercial)
- B. A grace period of six (6) months is provided for permit applications submitted to DCA ending **March 21, 2016**. Additional information on the code changes can be found here: <http://www.state.nj.us/dca/divisions/codes/codreg/>
- C. Short-term/FY16 program adjustments to be voted by BPU **today**. Look out for emails detailing program impacts.
- D. FY17 program changes to be released for Public Comment end of April (target).

Q: The public comment email sent out previously for P4P NC indicated that buildings permitted under the old code would continue to meet program requirements as they are currently, while projects permitted under new code would essentially have to demonstrate 15% energy cost savings from ASHARE 90.1-2013? Is that what is being voted on today?

A: Yes.

Q: What do you require for proof of permit?

A: The actual permit. If this is not yet granted, then confirmation of permit application submittal can be submitted initially and permit can follow after.

3. Notice: DLC De-listed Products

- A. Qualified Products List changes took effect 3/25/16. See complete notice here: <http://industries.ul.com/wp-content/uploads/sites/2/2015/07/DLC-Technical-Requirements-Update.pdf>

- B. Be sure that before purchasing LED lights/lamp fixtures you confirm that they are listed on the DLC Qualified Products List. If you purchased a product while it was listed, and it is now de-listed, the Program will still honor this product as long as you can demonstrate that it was purchased prior to the change of status (e.g. via invoices, etc.)

Q: How many products got de-listed? Was it a small change?

A: We don't have an actual number that were delisted. But DLC lists at least half a million products and this change did affect some existing SmartStart applications, so it was significant.

 - ii. All emails must contain Application Number (except new applications), Project Name, and Revision Number in the subject line.
 - iii. Resubmittals/revisions may be emailed directly to your reviewer but should CC P4P@njcleanenergy.com in the event a reviewer is out of the office, etc.
 - iv. Sub-consultants must CC partner of record on all email correspondence.
 - v. For bulk submittals (e.g. ESIP projects) we will be reaching out to the partner following application approval to advise on how best proceed with ERP submittals.
